In order to operate on or after July 1, 2023, an existing medical cannabis licensee or preapproved entity must pay the conversion fee and convert their license to a standard medical and adult-use license. Standard cannabis licenses will be valid for five years and will authorize a licensee to grow, process, or dispense both adult-use and medical cannabis. **Licenses who choose not to convert may continue to hold their license for resale, but may not operate under the license beginning July 1, 2023.**

The MCA encourages businesses to submit payment by June 16, in order to ensure the payment may be processed and the license converted in Metrc prior to July 1.
